### ABC Daily License Special Conditions

1. All proceeds generated from the sale of alcoholic beverages shall be directed to the non-profit organization issued a daily license by the California Department of Alcoholic Beverages Control (ABC)
2. The ABC-licensed organization shall supervise and control all sales, service and consumption of alcoholic beverages during the time and date in which the daily ABC-license has been issued. Only those persons(s) authorized by the licensee shall have the authority to sell or serve alcoholic beverages.
3. Persons under 21 years of age may not possess, purchase, or consume alcoholic beverages at any time.
4. The ABC-licensed organization shall have no less than three (3) members, 21 years of age or older, at each dispensing site. They shall be responsible for checking and verifying identification of patrons and issuing identifiable wristbands to those who purchase, possess, and consume alcoholic beverages. They shall be responsible for preventing the purchase and serving of alcoholic beverages to obviously intoxicated persons and preventing alcoholic beverages from leaving the designated consumption area(s).
5. Only those alcoholic beverages specified in the daily ABC-license are permitted on the premise during the time when the organization is licensed to sell and serve alcoholic beverages for the designated organization.
6. Alcoholic beverages may not be sold or dispensed in more than two (2) designated areas.
7. No more than two (2) alcoholic beverages may be sold to one (1) customer at time.
8. Wine and beverages containing distilled spirits must be served in plastic cups or glasses holding no more than 8 ounces. Beer must be served in plastic cups not to exceed 16 ounces.
9. Alcoholic beverages shall not be sold to or consumed by obviously intoxicated persons.
10. No less than two (2) signs at least 24" x 36" in size shall be prominently posted at the exits of each of the designated alcoholic beverage consumption area(s) stating, "NO ALCOHOLIC BEVERAGES BEYOND THIS POINT."

The sale and service of alcoholic beverages shall not begin before the designated start time of the event and must cease thirty (30) minutes before the scheduled end time of the event. Consumption of alcoholic beverages must cease thirty (30) minutes before the scheduled end time of the event. Consumption of alcoholic beverages must cease no later than the end time of the event listed on the ABC-221 form (Rev.03/22).

11. A copy of the daily ABC license authorizing the sales, service, and consumption of alcoholic beverage and a copy of these conditions shall be maintained at every point-of-sale location during the event.
12. Upon request of any peace officer, the ABC-licensed organization shall present a copy of the daily ABC license and these conditions. Upon demand of any peace officer the ABC-licensed organization shall immediately surrender the daily ABC license and cease all sales, service and consumption of alcoholic beverages.
13. In addition to any security guards, the ABC-licensed organization shall present a copy of the daily ABC license organization must designate no less than two (2) representatives, 21 years of age or older, to serve as liaisons to law enforcement officers when the daily ABC license is in effect.

I understand that the daily AB license may be revoked at any time by any peace officer, if it is determined that a violation of these conditions or any law occurred, and/or in the opinion of a police officer, it is necessary to protect the safety, welfare, peace and morals of the people of the State. Revocation of the daily ABV license may result in the denial of future daily license applications.**
