ENCROACHMENT PERMIT FEES TABLE (SIDEWALK, CURB & GUTTER, DRIVEWAY)

APPROXIMATE MINIMUM PERMIT FEES AND DEPOSITS

Permit Fee	\$65.00 (Non-Refundable)
Plan Review/Permit Issuance.....	Direct Costs
Estimated Inspection Deposit Minimum	\$387.00
Restoration	\$500.00 (min.)

The minimum inspection deposit is \$375.00. All charges to the job will be at an hourly rate shown on the City's Adopted Fee Schedule. The deposit will be increased based on the value of the work to be done or if additional inspections are expected. One (1) additional hour of inspection time will be required for each additional \$500.00 valuation of work.

Restoration Value		Inspection Deposit
\$500.00 or less..... (Base)	3 HR x \$129.00 = \$387.00	= \$387.00
\$501-\$1,000.00.....	1 HR x \$129.00 = \$129.00 + \$387.00 = \$516.00	
\$1,001.00-\$1,500.00.....	2 HR x \$129.00 = \$258.00 + \$387.00 = \$645.00	
Etc.		

The restoration deposit is based on the quantities of work to be done. The minimum deposit is \$500.00. The value of the work is calculated as follows:

SIDEWALK AREA:	Square Feet	x	\$ 20.00
CURB AND GUTTER:	Linear Feet	x	\$ 115.00
6" DRIVEWAY APPROACH:	Square Feet	x	\$ 21.00
8" DRIVEWAY APPROACH:	Square Feet	x	\$ 22.00
ADA RAMP:	Square Feet	x	\$ 30.00

Any unused portion of the Restoration and Inspection deposits will be refunded by the City Finance Department after receiving the Engineering Inspector's final approval.
