The City receives an annual allocation of funds from the U.S. Department of Housing and Urban Development (HUD) and through the County of Alameda HOME Consortium. Receipt of these funds requires the City to review its performance annually in meeting the housing and community development goals in the Five-Year Consolidated Plan.

The FY 2022-23 Consolidated Annual Performance Evaluation Report (CAPER) shall be available for **public review and comment** from **August 18, 2023, through September 18, 2023**.
